### **1 Croeso / Welcome**

Cadeiriwyd y cyfarfod gan Derek Owen ac fe groesawyd pawb oedd yn bresennol.  
*The meeting was chaired by Derek Owen and all present were welcomed.*

### **2 Datgan Diddordeb / Declaration of Interest**

Roger Dobson – Wylfa Newydd (caniatad arbennig / special dispensation)  
Elfed Jones – Prosiect Capel Bethlehem Project

Cafwyd ddiweddariad gan y clerc yn dilyn trafodaeth gyda Mared Yaxley, cyfreithiwr y pwyllgor safonau. Mae mwy o wybodaeth i ddilyn drwy ebost, fodd bynnag, bydd angen i Rhian Hayes ac elen Pritchard wneud cais llawn am ganiatad arbennig, tra bydd angen i'r HOLL aelodau eraill wneud cais ond cael eu cynrychioli gan y clerc yn y grandawriad.

Atgofir yr aelodau na ddylid annerch y Cyngor ar lafar nac yn ysgrifennedig ar unrhyw fater ble all fod ganddynt ddi-ddordeb rhagfarnol canfyddedig.

*An update was given by the clerk following discussion with Mared Yaxley, solicitor to the standards committee. Further information is expected by email, however both Rhian Hayes and Elen Pritchard will need to apply in full for special dispensation, whilst ALL other members will also have to apply but will be represented by the clerk in the hearing.*

*Members were reminded that should they have a perceived prejudicial interest in any topic/matter that they should not address the council either verbally or in writing.*

### **3 Capel Bethlehem**

Croesawyd Michelle Humphreys i'r cyfarfod. Cafwyd trosolwg o brosiect Capel Bethlehem hyd yma gan nodi bydd cyfarfod cyhoeddus arall i'w gynnal ym mis Medi i grynhoi'r ymatebion i'r ymgynghoriad. Mae arian wedi ei ddiogelu gan Cronfa Padrig tuag at datblygu cynlluniau manwl ac arolygon. Ar hyn o bryd mae gobeithio datblygu bwyty o safon a chyfleuterau gwyliau yn ogystal a chefnogi grwpiau cymunedol i ddatblygu atyniad twristiaeth e.e. Charles Henry Ashley.

Diolchodd Derek Owen i Michelle Humphreys am y ddiweddariad ggan nodi bod y Cyngor wedi bod yn gefnogol i'r prosiect mewn egwyddor o'r dechrau.

*Michelle Humphreys was welcomed to the meeting. An overview was given of the Capel Bethlehem project to date and it was noted that a further public meeting was due to be held in September to collate the response to the consultation. Funding has been secured from Cronfa Padrig towards developing surveys and detailed plans. At present it is hoped*

*to develop a quality restaurant and holiday let facility as well as supporting community groups to develop as a visitor attraction i.e. Charles Henry Ashley.*

*Derek Owen thanked Michelle Humphreys for the update and noted that the Council has been supportive of the project in principle from the onset.*

## **10 Wylfa Newydd**

### **10.1 Diweddariad Cyffredinol/General Update**

Fe gadarnhaodd Richard Foxhall bod y cais DCO wedi ei dderbyn gan yr arolygaeth gynllunio a bod gan rheini sydd a diddordeb 28 diwrnod i gofrestru er mwyn gallu cymryd rhan yn y broses i ystyried y cais. Nododd bod CNC yn ymgynghori ar hyn o bryd ar nifer o drwyddedau fyddai ei angen ar gyfer gweithredu'r orsaf pan wedi ei gwblhau. Cadarnhaodd y clerc bod eost gan CNC gyda amryw ddolenau wedi ei anfon ymlaen at yr aelodau. Gall y dogfennau ymgynghori hefyd cael eu canfod ar wefan Horizon.

Cadarnhaodd Richard Foxhall bod y cais cynllunio ar gyfer y gwelliannau priffyrdd 'ar lein' wedi ei ganiatau a bydd grandawriad ar gyfer pryniant gorfodol i'w gynnal ym mis Medi. CSYM fydd yn penodi contracwyr ac yn arsylwi'r gwaith. Dim ond ariannu'r agwedd yma o'r gwaith fydd Horizon. Nodwyd bod y gwelliannau o Fali hyd mynediad safle Wylfa Newydd ac nad oedd yn cynnwys Tregele. Nododd Richard Foxhall efallai byddai'r lon hyd at y fynedfa bresennol yn cael gwyneb newydd er ewyllys da gan fod peth gwaith Scottish Power ynghlwm a Wylfa Newydd.

Gobeithir bydd y cais cynllunio ar gyfer paratoi a chlirio'r safle yn cael ei ystyried gan Bwyllgor Cynllunio CSYM yn eu cyfarfod mis Medi.

Nodwyd bod 12 prentis yn cychwyn ar eu hyfforddiant ym mis Medi, y mwyafrif ohonynt o Fon. Mae'r dosbarth cyntaf ar eu blwyddyn diwethaf o hyfforddiant erbyn hyn, ac ar hyn o bryd yn Spaen ar brofiad gwaith, mae'r ail ddsbarth newydd ddychwely o Siapan. Bydd yr holl brentisiaid yn parhau ar brofiad gwaith cyflogedig byd eang nes bydd Wylfa Newydd yn weithredol.

Fe ofynnodd Roger Dobson am ddwieddarid am y cynllun hyfforddiant pynciau STEM yn yr ysgolion cynradd. Esboniodd Richard Foxhall bod hygredd y cynllun yn cael ei gwestiynu. Mae Horizon wedi cyflogi dau athro cynradd i ddatblygu prosiect sy'n cyrraedd gofynnion cwricwlwm yr ysgolion gyda cefnogaeth adran addysg CSYM. Pwrpas y prosiect yw cefnogi disgyblion i ddod ar afael a'r sgiliau a dealltwriaeth o bynciau STEM ac i adael ysgol gyda sgiliau a chymhwysterau perthasol ar gyfer cyflogaeth. Mae'r prosiect yn pwysleisio ar bynciau STEM ac nid ar y diwydiant niwclear.

Nododd Roger Dobson bod cwestiynnau yn parhau heb eu hateb, hyd yn oed wedi i'r cais DCO gael ei gyflwyno a bod y dogfennau erbyn ar hyn ar gael i'w darllen. Gofynnodd i Richard Foxhall os oedd mwy o wybodaeth ar gael am y 60 derbynnydd a fyddai yn cael eu heffeithio'n andwyol h.y. sain a dirgrynnu. Deallwyd bod ymchwil technegol pellach yn cael ei gwblhau ar hyn o bryd. Cytuno er mwyn gallu rhoi sylw ar dogfennau'r DCO a datblygiad Wylfa Newydd bod angen i'r wybodaeth berthnasol for ar gael ac i gwestiynnau gael eu hateb. Fe gytunodd Richard Foxhall byddai yn trefni i'r cynllun blastio gael ei gyflwyno i'r Cyngor yn y cyfarfod nesaf i egluro ymhellach.

Nododd Derek Owen bod Grwp Tregele Action Group wedi ei sefydlu'r swyddogol er mwyn rhoi llais i drigolion Tregele. GObeithir byddai Horizon yn cydnabod y grwp a'i bwysigrwydd. Nodwyd nad oedd nifer o drigolion Tregele yn mynychu'r sesiynnau agored a byddai posib trefnu cyfarfod arbennig yn swyddfeydd Horizon i gynnig cyfle i ofyn cwestiynnau a nodi eu pryderon. Roedd Richard Foxhall yn ymwybodol o'r grwp ac fe

gytunodd trafod a'r grwp i drefnu cyfarfod.

Mewn cyfarfod peth amser yn ol, nododd Horizon y byddent yn adeiladu canolfan cymunedol yn lle'r Clwb Cymdeithasol oedd i'w ddymchwel petai'r gymuned yn gallu adnabod lle cyn tir addas. Byddai'r adeilad newydd yn cael ei roi i'r gymuned i'w gynnal. Nododd Richard Foxhall bod dealltwriaeth ar y pryd mai'r gymuned oedd berchen ar yr adeilad ac nad oedd hyn yn wir, yr NDA oedd berchen ar yr adeilad. Fe gynnigodd Horizon adeiladu canolfan gyferbyn a'r fynedfa bresennol i'r safle ond fe wrthodwyd y cais gan CSYM. Ar sail hyn, fe gefnogwyd y grwpiau unigol i ganfon manau cyfarfod eraill.

Nododd Derek Owen bod cyfle euraidd i Horizon ddangos eu hymrwymiad i'r gymuned leol, a bod Oakfield Stores, Treglele i'w werthu mewn ocsiwn o fewn yr wythnos. Nododd Richard Foxhall nad oedd posib i Horizon gael eu gweld yn cefnogi'r gymuned yn ariannol tra bod y cais DCO yn cael ei ystyried gan y gall y fath gyfraniad gael ei weld fel llwgrwobrwyo. Gally fath drafodaethau fodd bynnag fod yn rhan o'r gytundeb cynllunio Adran 106.

Nododd Roger Dobson bod y cynnig i brynnu'r adeilad wedi ei drafod yng nghyfarfod y pwyllgor cyllid ac yn anffodus nad oedd gan y Cyngor asedau hylifol digonol, ond yn edrych ar oopsiynau gwahanol. Richard Foxhall ac Aled Jones i drafod ymhellach.

*Richard Foxhall confirmed that the DCO application had been accepted by the planning inspectorate and that interested parties would have 28 days to register in order to be able to participate in the decision making process. He noted that NRW are currently consulting on a number of permits required for the operation of the completed station. The clerk confirmed that the email from NRW with relevant links had been forwarded to all members for information. Consultation documentation can also be found on the Horizon website.*

*Richard Foxhall confirmed that planning consent for online road improvements had been granted and that a hearing regarding the compulsory purchase of land was due to take place in September. IACC will be appointing a contractor and overseeing the work and ultimately responsible for the work. Horizon's only involvement in this aspect of the work is funding the project. It was noted that the improvement work is from Valley to the new site entrance and will not include Treglele. Richard Foxhall noted that the road up to the current entrance may be resurfaced as a gesture of good will and to make right following substantial Wylfa Newydd related work by Scottish Power.*

*It is hoped that the planning application for site preparation and clearance can be considered at the September IACC Planning committee meeting.*

*It was noted that a further 12 apprentices will commence their training in September, the majority from the island. The first cohort of apprentices is on the last year of training and currently in Spain on work placement, the second cohort having just returned from Japan. All apprentices will remain on paid work placements world-wide until Wylfa Newydd is operational.*

*Roger Dobson asked for an update regarding the initiative for STEM subjects in the primary schools. Richard Foxhall explained that the integrity of the initiative was being criticised. Horizon has employed two primary school teachers to develop a project to meet the requirements of the school curriculum with the support of IACC education department. The aim of the project is to support pupils to obtain a good grounding and understanding of STEM subjects and to leave school with the skills and qualifications suitable for employment. The project focusses on STEM and is not nuclear specific.*

*It was noted by Roger Dobson that there were still unanswered questions, even with the DCO application submitted and the documents available to view. He asked Richard Foxhall if further information was available regarding the 60 residual receptors that would suffer major adverse effects i.e. noise and vibration. It was understood that further technical work was being undertaken at present. It was agreed that in order to comment on the DCO documentation and the development of Wylfa Newydd, the information must be made available and questions answered. Richard Foxhall agreed to arrange that the blasting strategy would be presented to the Council in September to provide further clarification.*

*Derek Owen noted that the Tregale Action Group had been formally established to provide the residents of Tregale with a voice. It was hoped that Horizon would acknowledge the group and its importance. It was noted that not many of the Tregale residents attended the open surgeries and that a special meeting may be arranged at the Horizon offices to provide an opportunity to ask questions and raise concerns. Richard Foxhall acknowledged the group and agreed to liaise with the group to arrange a meeting.*

*At a meeting some time ago, Horizon stated that if the community found a plot of land, that they could build a replacement facility for the Sports and Social Club that was to close and be demolished. The new building would then be given to the community. Richard Foxhall replied stating that at the time, it was understood that the Sports and Social Club belonged to the community and this was not the case – it actually belonged to the NDA. Horizon proposed to build a replacement facility on land opposite the current power station but permission as not granted by IACC. Horizon therefore supported the groups based at the club to find alternative venues.*

*Derek Owen explained that a golden opportunity had arisen for Horizon to show their commitment to the local community, and that Oakfield Stores, Tregale was to be auctioned in the next week or so. Richard Foxhall noted that Horizon cannot be seen to be supporting the community financially whilst the DCO is with the inspectorate for consultation as it may be considered a bribe. Such discussions could however form part of the Section 106 planning agreement.*

*Roger Dobson stated that the proposal to purchase the property had been discussed at the finance committee and that the Council unfortunately did not have the liquid resources required but were looking to explore different options. Richard Foxhall and Aled Jones to liaise and discuss further.*

## **10.2 Ymgynghoriad CNC/NRW Consultation**

*Mae sesiwn gwybodaeth i'w gynnal yn y neuadd Bentref 17/7/2018 ynglyn a'r ymgynghoriad. Nodwyd bod y trwyddedau a'r wybodaeth perthnasol yn dechnegol iawn. Mae dyddiad cau'r ymgynghoriad 6/9/2018. Cytuno byddai aelodau yn mynychu'r sesiwn ac adrodd yn ol os am i'r Cyngor ymateb.*

*An information session is to be held at the Village Hall 17/7/2018 regarding the consultation. It was noted that the permits and relevant information was very technical. The closing date for response is 6/9/2018. Members agreed to attend the session and report back if the Council was to submit a response.*

## **10.3 Tregale Action Group**

*Cafwyd cyflwyniad byr gan Kevin Barnett ar ran Grwp Tregale yn amlinellu prif bryderon y grwp yn ymwneud ag Wylfa Newydd. Mae trigolion Tregale yn bryderus iawn am y lonydd a thrafnidiaeth. Mae'r nifer o gerbydau am gynyddu'r sylweddol ac mae trigolion yn teimlo eu bod wedi eu carcharu yn y pentref – pa fesurau fydd yn cael eu rhoi yn eu lle i*

leihau'r nifer o gerbydau a lleihau'r effaith drwy Dregele? Pa fudd sydd i Dregele (ar wahan i adeilad posib)? Mae'r pryder, pwysau ac iselder sydd wedi ei achosi gan ddyfodol ansicir ac ddi-wybod yn cael effaith enfawr ar drigolion yn barod.

Hoffai trigolion Tregele weld cynllun yn dangos difrod a mesurau lliniaru – mae Horizon yn cyfeirio at gartrefni nid dim ond 'derbynyddion'. Mae'r gymuned, gan gynnwys plant a'r henoed yn haeddu cael eu diogelu a mesurau lliniaru addas yn cael eu rhoi yn eu mabwysiadu.

Cytuno byddai TAG yn cofrestru eu hunain gyda PINS er mwyn cael cymryd rhan yn y broses cynllunio.

Diolchodd y cynrychiolwyr i'r Cyngor am y gwahoddiad i gael dod i'r cyfarfod ac am eu cefnogaeth parhaol.

*Kevin Barnett gave a short presentation on behalf of the Tregele Action Group outlining the group's main concerns with regard to the Wylfa Newydd proposals. Tregele residents are very concerned about the roads and transport. The number of vehicles will increase significantly and residents feel trapped in the village – what measures will be put in place to reduce volume and calm traffic through Tregele? What benefit is there to Tregele (other than potentially a building)? The anxiety, stress and depression caused by the unknown and uncertain future is already having an enormous impact on residents.*

*Tregele residents wish to see a plan of anticipated damage and mitigation – Horizon are referring to homes not simply 'receptors'. The community, including children and the elderly deserve to be protected and suitable mitigation measures implemented.*

*It was agreed that the TAG would submit their own registration to PINS to be able to participate in the planning process considering the DCO application.*

*Representatives thanked the Council for the invitation to attend the meeting and for their ongoing support.*

#### **10.4 Datganiad Tir Cyffredin a Diffyg Gwybodaeth/Statement of Common Ground and Lack of Information**

Roedd pryder am y diffyg gwybodaeth oedd yn cael ei rannu gan Horizon wrth ystyried yr amserlen. Mae Partneriaeth Cynghorau Gogledd Mon, WOOD group, Roger Dobson ac aelodau eraill o'r Partneriaeth wedi gofyn am wahanol wybodaeth sydd hyd yma heb ei dderbyn na'i egluro. Mae dyddiad ar gyfer cyfarfod y Cyngor Cymuned a horizon i drafod y Datganiad Tir Cyffredin i'w gadarnhau. Y clerch i drefnu gydag aelodau'r is-bwyllgor.

*There was concern at the lack of information forthcoming from Horizon given the timescales. The North Anglesey Councils' Partnership, WOOD group, Roger Dobson and other members of the Partnership have requested various information that is yet to be received or clarified. A date for the community council to meet with Horizon to discuss the SOCG with Horizon is yet to be confirmed. The clerk to liaise with the sub group members.*

#### **10.5 Cofrestru gyda Comisiwn Seilwaith Cenedlaethol/Registration with National Infrastructure Commission**

Dosbarthwyd testun posib ar gyfer cofrestru'r Cyngor Cymuned gyda PINS gan Roger Dobson er mwyn i'r Cyngor gallu cymryd rhan yn y broses o ystyried y DCO. Roedd yr aelodau yn unfrydol yn eu cefnogaeth a diolchwyd i Roger Dobson am ei waith.

*Roger Dobson distributed possible text for the registration of the Community Council with PINS in order to take part in the DCO consideration process. Members were unanimous in support and Roger Dobson was thanked for his work*

*The response from IACC to date has been unsatisfactory. Immediate neighbours' concerns have not been addressed.*

*Carys Davies gave a summary of the last meeting was given by Carys Davies noting the main points discussed. The finance reports and committee's minutes are available for any member to view if they wish.*

Nodwyd bod Dafydd Williams wedi ymuno a'r pwyllgor, ac roedd y Cynghorwyr yn ei groesawu. Nodwyd bod y pwyllgor yn bryderus am Pier Bach a bod angen gweithredu, Nododd Derek Owen bod y Cyngor wedi rhoi'r piar yn ol i'r Goron 18 mlynedd yn ol bellach ac mai arnynt hwy oedd y cyfrifoldeb o'i gynnal. Mae CSYM wedi eu hysbysu o gyflwr y strwythr yn barod. Y clerch i gysylltu a'r Goron yn uniongyrchol. Roger Dobson i anfon lluniau diweddar i gefnogi'r llythyr.

*A report was distributed by Roger Dobson. A summary was given highlighting the main points of note by David Livingstone. It was noted that Dafydd Williams had joined the committee and the councillors welcomed him. It was noted that the committee were concerned with Piar Bach and that action was required. Derek Owen noted that the structure had been returned to the Crown Estate 18 years ago and that they were ultimately responsible for its maintenance. IACC have already been made aware of the current condition. The clerk to contact the Crown Estate directly. Roger Dobson to forward up to date photos to support the letter.*

Nododd Rhian Hayes bod ddiweddariad Treglele wedi ei gyflwyno eisioes, a bod y grwp yn ddiolchgar iawn am y cyfle i gael cwrdd a'r Cyngor.

*It was noted that the play area in Cemaes had been awarded the Keep Wales Tidy Green Flag award for the second year running. Agreed to order two colourful picnic tables for Cemaes and one for Treglele play areas. Elfed Jones to arrange.*

*Jack Longman has asked whether he could paint the window boards on the fitness club. There was no objection from the Council. Elfed Jones to make enquiries with the Club.*

*Rhian Hayes noted that the TAG update had already been given prior, and that the group were grateful for the opportunity to come and meet with the Council.*
