1 Croeso / Welcome

Cadeiriwyd y cyfarfod gan Derek Owen ac fe groesawyd pawb oedd yn bresennol. Nododd y Cadeirydd ei fod wedi derbyn llythyrau gan ddu aelod yn ymddiswyddo. Diolchodd i Rhian Hayes am ei hymrwymiad i'r Cyngor a chymuned Tregele tra yn aelod o'r Cyngor a dymuno'r gorau iddi yn ei chartref newydd. Cafwyd wybod bod David Livingstone wedi ymddiswyddo fel Cyngħoryyyd a hefyd yn rhinwedd y swydd honno, fel Cadeirydd Pwyllgor yr Harbwr. Mae wedi bod ynghlwm a'r pwyllgor ers blynyddoedd lawer. Cytuno ysgrifennu nodyn o ddiolch iddo am ei gyfraniad. Bydd y cleric yn cysylltu a'r swyddfa etholaeth i'r hysbysu bod dau sedd wag.

The meeting was chaired by Derek Owen and all present were welcomed. The Chair noted that he had received letters of resignation from two members. He thanked Rhian Hayes for her commitment to the Council and the community of Tregele whilst a member of the Council and wished her all the best in her new home. Those present were informed that David Livingstone had resigned as a Councillor, and thus also as Chair of the Harbour Committee. He has been involved with the committee for many years. Agreed to write a letter of thanks for his contribution. The clerk will be contacting the elections office to inform them of the two vacant seats.

4 Cofnodion Cyfarfod Diwethaf / Minutes of the Last Meeting

The minutes were confirmed correct. Proposed by Carys Davies seconded Elfed Jones.

10 Wylfa Newydd

Cafwyd ddiweddarriad gan Richard Foxhall a Delyth Owen o'r ddatblygiad y prosiect ar hyn o bryd. Dosbarthwyd adroddiad gan Roger Dobson yn dilyn cyfarfodydd diweddaraf Partneriaeth Cynghorau Gogledd Mon. Nodwyd bod cyfarfod wedi ei gynnwl gyda Gwen Parry-Jones a hefyd cyfarfod arall gyda Andy Hunt, arbennigwr lletya, er mwyn trafod yr agweddau hynnu o'r datganiad tir cyffredin.

Nodwyd bod y cais cynllunio i glirio a paratoi'r safle wedi ei gymeradwyo gan bwylgor cynllunio CSYM. Cafwyd wybod bod draftt cytundeb 106 wedi ei ddosbarthu wedi'r cyfarfod aelodau'r bartneriaeth ac nad oeddent yn hapus a'i gynnwys. Roedd cefnogaeth i ardaloedd Llanbadrig a Mechell nad oedd digon wedi ei gynnwys yn y ddogfen i lliniaru effeithiau'r gwaith. Roedd yr aelodau yn siomedig iawn bod y Cynghorwyr sirol wedi gallu cefnogi'r cais er wu bod yn gwybod bod y cymunedau lleol a'r bobl oedd wedi eu hethol yn aelodau CSYM yn gwrthwynebu'n gryf. Nodwyd teimlad yr aelodau nad oedd y Cynghorwyr Sirol yn gefnogol i'r ardal ac nad oeddent yn mynchyu cyfarfodydd y Cyngor Cymuned.

Fe gadarnhaodd Richard Foxhall mai hefo CSYM fydd trafodaethau Horizon yn ymwneud ag unrhyw gytundeb 106 a bod felly angen i'r cynghorau cymuned drafod hefo'u aelodau lleol a'r swyddogion perthnasol.

Nododd Richard Foxhall fod cyfarfod nesaf y grwp PLG i'w gynnal pnawn lau nesaf, a'i fod yn siomedig nad oedd cynrychiolaeth o Gyngor Llanbadrig wedi bod yn y cyfarfod diwethaf. Nodwyd ei fod yn annod i rheini sy'n gweithio fynychu cyfarfodydd sydd i'w cynnal yn y prynhawn. Mae hyn yn wir i gynrychiolwyr o gynghorau eraill hefyd nid yn unig i Lanbadrig,

Nododd Derek Owen bod teimlad yn y gymuned bod y Cyngor Cymuned yn elwa o brosiect Wylfa Newydd ac felly yn cefnogi pob cais heb gwestiynnu. Roedd yn bwysig bod bws ymgynghori / gwybodaeth Horizon yn ymweld a gwahanol lleoliadau ac yn rhannu gwybodaeth. Byddai posteri yn hyrwyddo lleoliadau o fudd. Delyth Owen i anfon y wybodaeth ymlaen i'r clerc i'w ddosbarthu i'r aelodau.

Cafwyd trafodaeth ynglŷn a gwersyll i 4000 ar safle datblygiad Wylfa Newydd a'r faith bod y gymuned yn gwrthwynebu hyn. Cydnabuwyd y byddai'n anhebygol iawn y byddai Horizon yn newid hyn am resymau ariannol. Cytuno bod angen felly pwysleisio a sicrhau bod mesuriadau lliniaru digonnol cael eu mabwysiadu

Cytuno trefnu cyfarfod nos Lun Hydref 1af am 7 o'r gloch i aelodau Cyngor Cymuned Llanbadrig a Cyngor Cymuned Mechell ar y cyd i drafod y Datganiad Tir Cyffredin, gwaharddiadau traffic a chytundeb 106 Wylfa Newydd. Y Clerc i anfon y ddogfen 106 i'r holl aelodau er gwybodaeth. Bydd cyfle i gwrdd a thraford ymhellach gyda Horizon wedi'r cyfarfod yma. Cytuno felly byddai'r Pwyllgor Cyllid yn cwrdd ar yr 8ed i drafod trin y fflat.

Nodwyd bod pryderon nid yn unig nad oedd Horizon yn rhannu gwybodaeth ond nad oedd CSYM ychwaith yn rhannu gwybodaeth gyda'r aelodau etholedig. Cytuno trefnu cyfarfod ar y cyd gyda Cyngor Mechell a'r chwe cynghorydd sirol sy'n cynrychioli Talybolion a Twrcelyn. Dyddiad ac amser i'w gadarnhau yn y cyfarfod 1/10/2018.

Richard Foxhall and Delyth Owen gave an update of the project development to date. Roger Dobson distributed a report following the North Anglesey Councils Partnership's latest meetings. It was noted that a meeting had been held with Gwen Parry Jones and a second meeting with Andy Hunt, accommodation specialist, in order to discuss that aspect of the statement of Common Ground.

It was noted that the planning application for site preparation and clearance had been approved by the IACC planning committee. A draft copy of the 106 Agreement has been circulated to the members of the NACP following the meeting and that they were not happy with its content. There was support to Llanbadrig and Mechell areas that there was not enough in the document to mitigate the impact of the proposed works. Members were very disappointed that the county councillors had been able to support the application knowing full well that the local communities and the people who had voted for them had objected strongly. It was noted that members felt that the county councillors were unsupportive of the local area and that they did not attend the community council meetings.

Richard Foxhall confirmed that any discussions regarding the 106 agreement will be between Horizon and IACC, and as such the community councils need to discuss with their local members and relevant officers.

Derek Owen noted that the community felt that the Community Council were benefitting from the Wylfa Newydd project and therefore supporting every proposal without question. It is important that the Horizon consultation/information bus visits different locations sharing information. Posters to promote dates, locations and times would be of benefit. Delyth Owen to forward the relevant information to the clerk to be distributed to members.

The members discussed the proposed camp for 4000 on site and the fact that the community was strongly opposed to the idea. It was agreed that it would be very unlikely that Horizon would change this for financial reasons. Agreed therefore to emphasise and press for sufficient mitigation measured to be adopted.

Agreed to arrange a joint meeting Monday October 1st at 7pm for members Llanbadrig Community Council and Mechell Community Council to discuss the statement of common ground, traffic restrictions and the Wylfa Newydd section 106 agreement. There will be an opportunity to discuss further with Horizon following this meeting. Agreed therefore that the finance committee will meet to discuss the flat on the 8th.

It was noted that there were concerns that not only did Horizon not share information, but that IACC did not share information with elected members either. Agreed to arrange a meeting with Mechell Community Council and the six county councillors representing Talybolion and Twrcelyn. Date to be confirmed at the meeting 1/10/18.

5 Materion yn codi o'r cofnodion / Matters arising from the minutes

5.1 Parth 20mya / 20mph Zone

Aled Jones i wahodd Alun Roberts (Prifyrdd CSYM) i fynychu cyfarfod mis Hydref. Nodwyd bod hefyd angen trafod y 'rat run' ar y cyd gyda Cyngor Mechell. Byddai cyfarfod ar y cyd y gyflle i drafod gyda aelodau lleol y ddau ward (Twrcelyn a Talybolion) hefyd o fudd gan nad oedd aelodau Llanbadrig yn teimlo bod y Cynghorwyr Sirol yn gwneud digon i gefnogi eu cymunedai lleol. Cytuno cwrdd ar y cyd gyda Mechell i drafod materion Wylfa Newydd gan gynnwys diogelwch ffordd.

Aled Jones to invite Alun Roberts (IACC Highways) to the October meeting. Noted that the 'rat run' also needed considering in partnership with Mechell Council. A joint meeting with the local members for both Twrcelyn and Talybolion would also be of benefit as Llanbadrig councillors did not feel that the county councillors were doing enough to support their local communities. Agreed to arrange a joint meeting with Mechell to discuss Wylfa Newydd and road safety matters.

5.2 Oakfield Stores

Nodwyd bod yr adeilad wedi ei werthu.
It was noted that the building has sold.

5.3 Pier Bach

Nododd y clerc ei bod wedi cysylltu a'r Goron ond nad oedd ymateb hyd yma. Rhaid disgwyl ymateb cyn cymryd unrhyw gamau pellach.

The clerk noted that contact has been made with the Crown Estate and that no reply has been received as yet. Until a response has been received, no further action can be taken.

6 Adroddiad Pwyllgor Cyllid / Finance Committee Report

Cafwyd grynodeb o'r cyfarfod diwethaf gan Carys Davies gan nodi y prif bwyntiau a drafodwyd. Mae adroddiadau cyllidol a chofnodion llawn y pwyllgor ar gael i unrhyw aelod sydd am eu gweld er gwybodaeth. Roedd y Cyngor Llawn yn hapus i fabwysiadu'r

Rheoliadau Ariannol ac Asesiad Risg fel y cyflwynwyd gan y pwyllgor. Diolchwyd i'r pwyllgor am eu gwaith.

Carys Davies gave a summary of the last meeting was given by Carys Davies noting the main points discussed. The finance reports and committee's minutes are available for any member to view if they wish. The Full Council were happy to adopt the Financial Regulations and Risk Assessment as presented by the committee. The committee were thanked for their work.

7

Rheolaeth yr Harbwr / Harbour Management

Dosbarthwyd adroddiad gan Roger Dobson. Nododd Roger Dobson bod David Livingstone wedi ymddiswyddo o'r pwyllgor; mae cyfansoddiad y pwyllgor yn nodi bod pedwar cynrychiolydd o'r Cyngor, ac mai'r Cyngor sydd yn penodi Cadeirydd. Cynnigodd Elfed Jones y byddai Roger Dobson yn gadeirydd, eilio gan Brian Potter. Bydd felly angen i'r pwyllgor benodi ysgrifennydd newydd. Penodwyd Brian Potter yn bedwerydd cynrychiolydd ar ran y Cyngor. Cynnig Derek Owen, eilio Jack Longman.

A report was distributed by Roger Dobson. He noted that David Livingstone had resigned from the committee; the terms of reference note that there are four council representatives, and that the Council appoint the Chairperson. Elfed Jones proposed Roger Dobson as Chair, Brian Potter seconded. The committee will therefore have to appoint a new secretary. Brian Potter was nominated the fourth council representative on the committee. Proposed Derek Owen, seconded Jack Longman.

8

Pwyllgor y Pentref / Village Committee

Cafwyd ddiweddarriad gan Rhian Hayes am weithgaredadu'r TAG. Roedd yn ddiolchgar bod y grwp yn cael eu cydnabod gan Horizon a'r Cyngor Cymuned, a gobeithir byddai'r grwp yn parhau i ddatblygu a tyfu. Nododd bod hysbysfrwdd dros dro wedi ei osod yn y prentref yn lle'r un sydd wedi ei ddrifrodi. Diolchwyd i Rhian Hayes am ei gwaith gyda'r TAG, gan nodi byddai'r Cyngor Cymuned yn parhau i'w cefnogi. Nodwyd pryderon bod talcen adeilad y Douglas ar fin dymchwel ac angen sylw ar frys.

Rhian Hayes gave an update of the TAG's activities. She was grateful that the group are recognised by both Horizon and the Community Council, and hoped that the group would continue to grow and develop. It was noted that a temporary notice board had been erected in the village in place of the one damaged. Rhian Hayes was thanked for her work with the TAG, noting that the Council will continue to support them. Concerns were noted that the gable end of the Douglas required urgent attention and was about to collapse.

9

Cynllunio / Planning

Wrth ystyried penderfyniadau diweddar, fe ofynnwyd os oedd pwrrpas mynegi barn ar geisiadau cynllunio os nad oedd swyddogion nag aelodau lleol CSYM am eu cydnabod a mynd yn groes i ddymuniadau'r gymuned. Nododd Roger Dobson bod y broses o ystyried y DCO ar gyfer Wylfa Newydd yn annibynnol o CSYM a bod y Cyngor Cymuned ynghyd a Partneriaeth Cynghorau Gogledd Mon wedi cofrestru er mwyn cael cymryd rhan yn y broses honno.

Considering recent decisions, it was asked whether there was any purpose commenting on planning applications if neither the IACC officers nor local members were to acknowledge any comment and go against the wishes of the community. Roger Dobson noted that the process to consider the DCO was independent to the IACC and that the Community Council as well as the North Anglesey Councils Partnership had registered to be able to participate in the process.

Ysgolion Cynradd / Primary Schools

Nodwyd siom yr aelodau bod CSYM, yn ol datganiad yn y wasg, yn edrych ar y posibilrwydd o gau ysgolion cynradd y dalgylch (pob un dan 120 o ddisgyblion) ac addasu rhan o adeilad Ysgol Syr Thomas Jones ar gyfer addysg cynradd. Roedd yr aelodau yn gwrthwynebu'r cynnig yn gryf.

Members noted their disappointment that IACC, according to a statement in the press, are looking at the possibility of closing all primary schools in the area (under 120 pupils) and adapting part of Ysgol Syr Thomas Jones school for primary education. Members strongly objected to the proposal.

Nododd Carys Davies bod gwirfoddolwr wedi bod yn symud y biniau o'r fynwent i'r lon pob tro eu bod angen eu gwagio ond nad oedd yn gallu gwneud mwyach. Diolchwyd i Jack Longman

am gynnig gwneud y gwaith. Nodwyd bod angen edrych ar drin ac adnewyddu'r llwybr i'r fynwent ymhent amser.

Carys Davies noted that a volunteer had been moving the bins from the cemetery to the road to be emptied and that they were no longer able to do so. Jack Longman was thanked for offering to do the work. It was noted that the path up to the cemetery will need attention in due course.

12.5 Fforwm Cyswllt / Liaison Forum

Cafywd cryniodeb gan Brian Potter o'r hyn a drafodwyd gan y pwylgor yn y cyfarfod diwethaf. Nodwyd bod ardaloedd eraill hefyd yn pwysio ar CSYM am ddatblygu ardaloedd 20mya. Bydd cyfarfodydd i drafod canlyniadau'r arolwg siapio cymunedau'n fuan. Nid oes dyddiad hyd yma.

Brian Potter gave a summary of the discussions at the last meeting. It was noted that other areas are also pressing on IACC to develop 20mph zones. A meeting to discuss the results of the place shaping consultation is due to take place soon. There is no date as yet.
