Cofnodion o gyfarfod y Cyngor Llawn a gynhaliwyd nos Lun 17/12/2018 **Minutes of the Full Council meeting held on Monday evening 17/12/2018**

1 Croeso / Welcome

Cadeiriwyd y cyfarfod gan Derek Owen ac fe groesawyd pawb oedd yn bresennol. Nododd nad oedd y Cyngor wedi gallu cynnal y cyfarfod mis diwethaf oherwydd diffyg presenoldeb.

The meeting was chaired by Derek Owen and all present were welcomed. He noted that the Council had not been able to conduct the November meeting due to lack of attendance.

2 Datgan Diddordeb / Declaration of Interest

3 Caniatad Arbennig / Special Dispensation

Cadarnhawyd bod y ffurflenni hynnu sydd wedi eu cwblhau wedi eu cyflwyno i'r Pwyllgor Safonau. Nododd y clerc bod ganddi fwy o ffurflenni os oedd unrhyw un arall am eu cwblhau.

It was confirmed that the completed forms had been presented to the Standards Committee. The clerk noted that she had copies of the form should any one else wish to complete it.

10 Wylfa Newydd

Cafwyd ddiweddariad gan Richard Foxhall o'r hyn sy'n digwydd ar hyn o bryd a'r system gynllunio ynghyd a'r amserlen ar gyfer ystyried y cais DCO. Nododd siom bod Llywodraeth Cymru nawr yn ystyried cais cynllunio clirio a paratoi'r safle gan nad oeddent wedi bod yn hapus a'r ffordd oedd CSYM wedi ei gymeradwyo. Nododd bod y gwaith angenrheidiol yma hefyd wedi ei gynnwys o fewn y cais DCO. Disgwylir penderfyniad yr arolygwr ar y cais ddiwedd Hydref 2019.

Nododd Roger Dobson bod y cyngor cymuned yn gwrthwynebu cais Horizon i glirio a pharatoi'r safle cyn i'r cais DCO gael ei gymeradwyo a chyn i arian gael ei ddiogelu i ddatblygu'r prosiect. Roedd yr aelodau wedi bod yn siomedig iawn gyda CSYM am gymeradwyo'r cais oherwydd pryderon am amseru'r gwaith a chanlyniad y DCO.

Fe ofynnodd Roger Dobson eto am wybodaeth pellach ynglyn a'r eiddo a thrigolion fydd yn cael eu heffiethio fwyaf – '*residual receptors*'. Fe ofynnodd am y wybodaeth yma yn wreiddol yn ol ddechrau mis Gorffennaf. Pwysleisiodd nad oedd angen gwybod pwy fydd yn cael eu heffeithio, ond yn hytrach y broses a'r amserlen i ddelio a'r effaith andwyol yma.

Mae Roger Dobson yn parhau i ddisgwyl am wybodaeth pellach ynglyn ag oriau gweithio hefyd, er ei fod wedi dod a'r mater i sylw pob cyfarfod ers rhai misoedd ac wedi sgwrsio ag nifer o gynrychiolwyr Horizon gan gynnwys Charlie Tasker yn y gymorthfa ddiwethaf.

Nodwyd bydd angen cyflwyno draft terfynnol y datganiad tir cyffredin yn fuan. Pwysleiswyd nad oedd y cyngor yn gallu trafod a dod i gytundeb os nad oedd y wybodaeth yn cael ei gyflwyno a chwestiynau yn cael eu hateb.

Diolchwyd i Richard Foxhall am fynychu'r cyfarfod, a nifer o gyfarfodydd eraill dros y flwyddyn diwethaf. Bu iddo adael y cyfarfod am 7.30.

Richard Foxhall gave a summary of project activities and the planning system along with a timetable for the DCO process. He noted disappointment that the Welsh Government were not considering the planning application for site preparation and clearance as they were not happy with the measures taken by IACC to determine the approval. This essential work has also been included within the DCO application. The inspectorate's decision is expected in October 2019.

Roger Dobson noted that the community council had opposed Horizon's application for site preparation and clearance prior to the approval of the DCO and funding being secured to develop the project. The members were very disappointed with IACC for approving the planning application due to concerns with the timing of the work and the outcome of the DCO application.

Roger Dobson asked again for further information regarding the properties and residents identified as being most affected – the residual receptors. He originally requested this information back at the beginning of July. He emphasised that he does not need to know who will be affected but rather the process and timescale to deal with the negative impact.

Roger Dobson is still waiting on further information regarding working hours, even though he has brought the matter to the attention of every meeting for some months and has spoken to a number of different Horizon representatives including Charlie Tasker at the last surgery.

It was noted that the final draft of the statement of common ground was to be submitted soon. It was emphasised that the council were unable to discuss matters and come to an agreement of the information is not provided and questions remain unanswered.

Richard Foxhall was thanked for attending the meeting and numerous other meetings throughout the year. He left the meeting at 7.30.

4 Cofnodion Cyfarfod Diwethaf / Minutes of the Last Meeting

Derbyniwyd y cofnodion yn gywir. Cynigwyd gan Roger Dobson eiliwyd gan Enid Jones. The minutes were confirmed correct. Proposed by Roger Dobson seconded Enid Jones.

5.1 Seddi Gwag/Vacant Seats

Mae tri sedd wag a pedwar ymgeisydd. Cytuno byddai Derek Owen, Carys Davies, Enid Jones ac Elfed Jones yn cyfweld a'r ymgeiswyr cyn cyfarfod y pwyllgor cyllid 8/1/2019 ac yn adrodd yn ol gyda'u argymheliad yn y cyfarfod nesaf.

There are three vacant seats and four applicants. Agreed that Derek Owen, Carys Davies, Enid Jones and Elfed Jones interview the applicants before the next finance meeting 8/1/2019 and report back with their recommendations at the next meeting.

5.2 Materion Priffyrdd/Highway Matters

Nodwyd bod yr aelodau wedi cwrdd a'r cynghorwyr sirol a bod disgwyl ymateb pellach. Mae swyddogion CSYM hefyd yn ymwybodol o bryderon y cynghorau lleol (Llanbadrig a Mechell).

It was noted that the members have met with the county councillors and that further response is anticipated. IACC officers are also aware of the local councils' concerns (Llanbadrig and Mechell)

5.3 Cyfarfod Choeddus Glendid Dwr/Water Quality Public Meeting

Cytuno dylid gynnal cyfarfod cyhoeddus 21/2/2019, Elfed Jones i gadarnhau argaeledd y Neuadd a Derek Owen i gysylltu a'r asiantaethau perthnasol.

Agreed that a public meeting should be held 21/2/2019, Elfed Jones to confirm availability of the Hall and Derek Owen to contact the relevant agencies.

5.4 Pier Bach

Nid oedd diweddariad gan y Goron, y clerch i gysylltu eto.

No update from the Crown Estate, the clerk to make contact again.

5.5 Siapio Cymunedau / Place Shaping

Nodwyd bod cyfarfod arall wedi ei drefnu ar gyfer diwedd mis Ionawr.

It was noted that another meeting had been arranged for January.

6 Adroddiad Pwyllgor Cyllid / Finance Committee Report

Cafwyd grynodedb o'r cyfarfod diwethaf gan Roger Dobson gan nodi y prif bwyntiau a drafodwyd. Bydd cyfarfodydd penodol i'w trefnu ar gyfer mis Ionawr i drafod 10 Stryd Fawr, y gyllideb a'r prisedd ar gyfer 2019/20 a'r cofrestr asedau.

Roger Dobson gave a summary of the last meeting the main points discussed. Specific meetings will be arranged in January to discuss 10 High Street, the budget and precept for 2019/20 and the asset register.

7 Rheolaeth yr Harbwr / Harbour Management

Dosbarthwyd adroddiad gan Roger Dobson drwy ebost cyn y cyfarfod. Nodwyd bod yr anghydfod ynglwm a thaliad wedi ei ddatrys bellach. Cafwyd grynodedb am ddatblygiad y system CCTV fydd ynghlwm a system a pholisiau'r Cyngor. Bydd tri aelod o'r pwyllgor yn cael eu hyfforddi i ddefnyddio'r system. Pwysleiswyd pwysigrwydd cadw at bolisi a chanllawiau'r Cyngor Cymuned. Cafwyd wybod nad oedd y pwyllgor wedi bod yn llwyddianus yn diogelu arian grant tuag at y prosiect.

A copy of Roger Dobson's report was distributed by email prior to the meeting. It was noted that the disagreement regarding payment has now been resolved. A summary was given about the development of the CCTV system that will be in line with the Council's system and policies. Three members of the committee will be trained to use the system. The importance of adhering to Community Council policy and guidance was emphasised. It was reported that the committee had not been successful in securing grant funding towards the project.

8 Pwyllgor y Pentref / Village Committee

Nodwyd bod dwy mainc newydd i'w gosod ger Marine Terrace. Nodwyd bod Elfed Jones ac Enid Jones yn cydweithio i gael arwydd newydd ar waelod allt Castellior cyn gynted a phosib. Mae Elfed Jones ac Enid Jones hefyd yn edrych ar y posibilrwydd o symud y llwybr ger Cae Adda fel nad yw rheini sydd yn ei ddefnyddio yn mynd drwy iard y fferm.

Bydd Dei Owens yn cysylltu a pherchnogion y garej yn Nhregele a hefyd Horizon i geisio datrys y broblem parcio ar y glaswellt ar ymyl y ffordd ger y garej.

Nodwyd bod angen diweddarau'r rhestr aelodau a gwybodaeth sut i gael gweld cofnodion y Cyngor yn yr hysbysfwrdd.

It was noted that there were two new benches to be installed near Marine Terrace. It was noted that Elfed Jones and Enid Jones were working together to have a new sign at the bottom of Castellior hill as soon as possible. Elfed Jones and Enid Jones also look at the possibility of moving the path near Cae Adda so that those who use it do not go through the farm yard.

Dei Owens will contact the owners of a garage at Tregele and also Horizon to try and resolve the parking problem on the grass at the edge of the road near the garage.

It was noted that the list of members and information needs to be updated on how to access Council minutes in the notice board.

It was confirmed that the Council has registered with PINS to be able to participate in the planning process.

12 **Ymgynghoriad Ysgolion / Schools Consultation**

Cadarnhaodd y clerc ei bod wedi ymateb i'r ymgysylltiad gan gydnabod derbyn y dogfennau a chadarnhau na fyddai'r Cyngor yn ymateb yn ffurfiol nes bydd gwybodaeth cyflawn ar gael. Nodwyd bod yr aelodau yn gyffredinol yn gwrthwynebu cau ysgolion gwledig wrth gydnabod gwerth addysg ac ysgol mewn cymuned gwledig. Mae disgwyl gwybodaeth pellach gan CSYM yn y flwyddyn newydd.

The clerk confirmed that she had responded to the engagement acknowledging receipt of the documents and confirmed that the Council would not respond formally until full information was available. It was noted that members generally opposed the closure of rural schools in recognizing the value of education and school in a rural community. Further information from IACC is expected in the new year.
