**Cofnodion o gyfarfod y Cyngor Llawn a gynhaliwyd nos Lun 15/7/2019
Minutes of the Full Council meeting held on Monday evening 15/7/2019**

1 Croeso / Welcome

Cadeiriwyd y cyfarfod gan Derek Owen, croesawodd bawb i'r cyfarfod. Cyn y cyfarfod ei hun, diolchodd Derek Owen i Aled Jones am ei ran yn sicrhau £500k gan yr NDA tuag at brosiectau yng ngogledd Ynys Môn. Awgrymwyd y dylid gwahodd Dylan Williams (datblygu economaidd) i'r cyfarfod nesaf i drafod sut y byddai Cyngor Sir Ynys Môn (CSYM) yn gweithio gyda'r cymunedau perthnasol.

The meeting was chaired by Derek Owen, he welcomed all to the meeting. Prior to the meeting proper, Derek Owen thanked Aled Jones for his part in securing £500k from the NDA towards projects in North Anglesey. It was suggested that Dylan Williams (economic development) be invited to the next meeting to discuss how CSYM would be working with the relevant communities.

3 Cofnodion y Cyfarfod Diwethaf / Minutes of the Last Meeting

Cadarnhawyd bod y cofnodion yn gywir. Fe'u cynigiwyd gan Elfed Jones a'u heilio gan Carys Davies.

The minutes were confirmed correct. Proposed by Elfed Jones seconded Carys Davies.

4 Materion yn codi o'r cofnodion / Matters arising from the minutes

4.1 Sedd Wag / Vacant Seat

Cadarnhawyd bod y swyddfa etholiadol yn ymwybodol o ymddiswyddiad Roger Dobson a bod y broses i benodi cynghorydd newydd ar y gweill

It was confirmed that the electoral office was aware of Roger Dobson's resignation and that the process to appoint a new councillor was underway.

4.2 Materion Priffyrd / Highways Matters

Roedd e-bost oddi wrth Alun Roberts yn cynnig codi arwydd dim parcio dros nos ar gyfer carafanau a thai modur ('motorhomes') yn y gilfan ger Buarth y Foel a Ffordd y Traeth. Dim gwrthwynebiad i'r cynnig.

Rhoes e-bost oddi wrth Huw Percy y wybodaeth ddiweddaraf am faterion priffyrd eraill, a safiad presennol CSYM a Heddlu Gogledd Cymru mewn perthynas â chyfyngiadau cyflymder yn y gymuned. Nododd Elfed Jones, yn dilyn cyfarfod safle mewn perthynas â chynnig

Tregele ar gyfer tirlunio, y gallai fod yn bosib ymgorffori diogelwch ar y ffyrdd fel rhan o'r prosiect.

An email from Alun Roberts proposed to erect a no over night parking sign for caravans and motorhomes at both the layby near Buarth y Foel and Ffordd y Traeth. No objection to the proposal.

An email from Huw Percy gave an update on other highways matters, and the current stance of CSYM and North Wales Police in relation to speed restrictions in the community. Elfed Jones noted that following a site meeting in relation to the Tregele proposal for landscaping, it may be possible to incorporate road safety as part of the project.

5 Adroddiadau Pwyllgorau / Committee Reports

5.1 Adroddiad y Pwyllgor Cyllid / Finance Committee Report

Rhoes Derek Owen drosolwg o gyfarfod y pwyllgor cyllid. Nododd fod gwaith adnewyddu'r fflat bron wedi'i gwblhau a diolchodd i Brian Potter am ei ymrwymiad i'r prosiect. Nodwyd bod tri dyfynbris wedi dod i law hyd yn hyn ar gyfer y gwaith angenrheidiol i lwybr y fynwent. Roedd disgwyl dau ddyfynbris arall. Roedd rhestr o daliadau a'r adroddiad cyllid chwarterol ar gael i aelodau pe dymunent drafod ymhellach. Dosbarthwyd copïau o adroddiad ysgrifenedig yr archwiliwyr mewnol i'r rhai oedd yn bresennol, er gwybodaeth

Derek Owen gave an overview of the finance committee meeting. He noted that the refurbishment of the flat was near completion and thanked Brian Potter for his commitment to the project. It was noted that three quotes had been received to date for the necessary work to the cemetery path. A further two quotes were expected. A list of payments and the quarterly finance report is available to members should they wish to discuss further. Copies of the internal auditors written report were distributed to those present for information.

5.2 Pwyllgor Parciau a Mannau Agored / Parks and Open Spaces Committee

Rhoes Elfed Jones drosolwg o'r cyfarfod diwethaf lle cytunwyd i flaenoriaethu'r prosiectau ar gyfer Tregele a Marine Terrace. Roedd angen gwneud gwaith pellach i ddatblygu manylion y prosiectau. Nodwyd bod angen rhywfaint o waith cynnal a chadw ym Monc y Môr i wella golygfa'r ardal. Roedd angen gwaith hefyd ar y wal derfyn rhwng Tudor Royal a Maes Padrig. Nid oedd yn eglur pwy sy'n gyfrifol am y wal ar hyn o bryd.

Elfed Jones gave an overview of the last meeting where it was agreed to prioritise the projects for Tregele and Marine Terrace. Further work is required to develop the detail of the projects. It was noted that some maintenance was required at Bonc y Mor to improve the outlook of the area. Work was also required to the boundary wall between Tudor Royal and Maes Padrig. It is unclear who is responsible for the wall at present.

5.3 Rheolaeth yr Harbwr / Harbour Management

Dosbarthwyd yr adroddiad misol i'r holl aelodau trwy e-bost cyn y cyfarfod. Rhoes Tim Turner drosolwg o'r cyfarfod. Nododd fod y pwyllgor yn gobeithio gosod camera teledu cylch cyfyng ychwanegol yn agosach at fynedfa'r pier. Cytunwyd y gallai'r camera hwn (ar gost o oddeutu £350) gael ei ymgorffori yn yr uwchraddiad sy'n ofynnol i ddod â'r tair system ynghyd yn y ganolfan dreftadaeth dros yr wythnosau nesaf.

Cadarnhawyd bod y cyngor yn cefnogi asesiad risg ac argymhellion y pwyllgor, ac yn cymeradwyo'r system gwneud cais am angorfa.

Nododd Derek Owen fod rhai materion yn y cofnodion yn gofyn am sylw ac eglurhad pellach y byddid yn ymdrin â nhw yng nghyfarfod mis Awst. Nododd ei fod yn cadeirio cyfarfodydd

pwylgor yr harbwr ar hyn o bryd nes bod Brian Potter mewn sefyllfa i gymryd y gadair. Pe na byddai Derek Owen na Brian Potter yn bresennol, byddai aelod arall o'r cyngor yn cadeirio'r cyfarfodydd.

Gofynnodd Tim Turner pwy oedd yn gyfrifol am orfodi achosion o dorri terfynau cyflymder yn y bae. Nodwyd mai cyfrifoldeb CSYM fyddai hyn. Byddai'n bosib defnyddio'r system teledu cylch cyfyng i fonitro troseddwyr mynch a rhoi gwybod i GSYM.

The monthly report had been circulated to all members by email prior to the meeting. Tim Turner gave an overview of the meeting. He noted that the committee hoped to install an additional CCTV camera closer to the entrance of the pier. It was agreed that this camera (at a cost of approx. £350) could be incorporated into the upgrade required to bring the three systems together at the heritage centre over the coming weeks.

It was confirmed that the council support the committee's risk assessment and recommendations, and endorse the mooring application system.

Derek Owen noted that there were some issues in the minutes requiring further attention and clarification at that they would be addressed at the August meeting. He noted that he was chairing the harbour committee meetings at present until Brian Potter was in a position to take the chair. Should neither Derek Owen or Brian Potter be present, the meetings would be chaired by another council member.

Tim Turner asked who was responsible for enforcing breach of speed limits in the bay. It was noted that responsibility would lie with CSYM, it would be possible to use the CCTV system to monitor repeat offenders and report to CSYM.

Rhoes Aled Jones y wybodaeth ddiweddaraf am sefyllfa bresennol Ilywodraeth y Deyrnas Unedig o ran ynni niwclear.

Nododd Derek Owen ei fod wedi llwyddo i sicrhau adeilad Horizon i'w ddefnyddio gan grŵp Charles Henry Ashley a grwpiau cymunedol eraill.

Gyda Roger Dobson wedi ymddiswyddo yn y cyfarfod diwethaf, cytunwyd y byddai Carys Davies yn cynrychioli'r cyngor ar SSG Magnox ynghyd â Derek Owen.

Aled Jones gave an update as to the UK government current state of play with regard to nuclear power.

Derek Owen noted that he had been successful in securing a Horizon building for use by the Charles Henry Ashley and other community groups.

With Roger Dobson's resignation at the last meeting, it was agreed that Carys Davies would represent the council on the Magnox SSG along with Derek Owen.

8.1 Gohebiaeth / Correspondence
Enwebwyd Elfed Jones yn Hyrwyddwr yr Iaith Gymraeg y cyngor at ddiben bodloni polisi Iaith Gymraeg CSYM.

Elfed Jones was nominated the council's Welsh Language Champion for the purpose of satisfying the CSYM Welsh Language policy.

Notice of road closure and temporary diversions.

- 8.3** Ymgynghoriad Gosod Tai CSYM - cadarnhawyd bod y wybodaeth wedi'i hanfon at aelodau trwy e-bost cyn y cyfarfod. Rhyfeddodd yr aelodau bod angen ymgynghori ynghylch a ddylid ystyried cysylltiad lleol wrth osod tai cymdeithasol. Roedd yr aelodau'n teimlo'n gryf y dylid, wrth osod tŷ, roi blaenoriaeth i bobl leol oedd wedi byw yn yr ardal, oedd â theulu agos yn yr ardal neu oedd wedi gweithio yn yr ardal am gyfnod o bum mlynedd neu fwy. Dylid ystyried y diffiniad 'lleol' hefyd wrth ddechrau gyda'r gymuned ei hun cyn ystyried y ward etholiadol ac yna'r sir, gan flaenoriaethu pobl Llanbadrig, yna Twrcelyn ac yna Ynys Môn. Mae pwysigrwydd cymuned a chefnogaeth teulu a ffrindiau yn amhrisiadwy ac mae llawer o bobl yn dibynnu ar y gefnogaeth hon yn eu bywydau bob dydd.

CSYM Housing Allocation consultation – it was confirmed that the information had been sent out to members by email prior to the meeting. Members were amazed that there was a need for consultation on whether a local connection should be taken into account when allocating social housing. Members felt strongly that local people who had lived in the area, had a close family in the area, or had worked in the area for a period of five years or more should be given priority when letting a house. The definition of 'local' should also be considered when starting with the community itself before considering the electoral ward and then the county. foregrounding the people of Llanbadrig, then Twrcelyn and then Anglesey. The importance of community and the support of family and friends is invaluable, and many people rely on this support in their daily lives.
