*Section 106 site preparation and clearance – the county councillors have agreed to discuss the draft document in detail at the next meeting held with the two councils and county representatives.*

*Roger Dobson noted that he intended to attend the meetings at Mona as part of the DCO process. Agreed that he would represent the Council to raise awareness about the main points of concern.*
