1 Croeso ac Ymddiheuriadau / Welcome and Apologies

Bu Carys Davies groesawu pawb i'r cyfarfod, bu iddi dynnu sylw'r aelodau ar dechrau'r cyfarfod at lythyr a dderbyniwyd gan y clerc yn ymddiswyddo. Bu diolch i'r clerc am ei gwaith dros y ddegawd diwethaf. Nodwyd byddai'r pwyllgor cyllid yn cwrdd cyn gynted a phosi i drefnu hysbysebu'r cyfle.

Carys Davies welcomed all to the meeting, she drew the members' attention at the beginning of the meeting to a letter of resignation received from the clerk. The clerk was thanked for her work over the last decade. It was noted that the finance committee would meet as soon as possible to organise advertising of the position.

5 Diweddariadau / Update

5.1 Cyllid a Personel / Finance and Personnel

Cafwyd crynodeb o'r cyfarfod diwethaf gan Enid Jones. Cafwyd ddiweddariad am brynnu tir ar gyfer mynwent y Rhyd, a chwblhau yr arolygon perthnasol ar gyfer cael caniatad cynllunio arno. Cymeradwywyd nifer o daliadau a penderfynnwyd ystyried dau gais am arian (ffermwyr ifanc ac ambiwlans awyr) ar ddiwedd y flwyddyn ariannol yn ddibynnol ar y gyllideb. Derbyniwyd adroddiadau cyllid misol a chwarterol, a hefyd adroddiadau chwarterol y caeau chwarae. Nodwyd bod ambell beth angen sylw yn y caeau chwarae a bod hyn eisioes ar y gweill. Cadarnhawyd bod y dogfennau perthnasol ar gyfer yr archwiliad allannol wedi eu hanfon at yr achwiliwr allannol a byddai'r broses yn cymryd hyd at flwyddyn i'w gwblhau. Trafodwyd opsiynnau posib ar gyfer debryn taliadau cerdyn ar gyfer parcio, mae angen trafod eto cyn dod i unrhyw benderfyniad. Bydd y pwyllgor yn cwrdd nos Lun i drafod hysbysebu swydd y clerc.

Enid Jones gave a summary of the last meeting. There was an update on the purchase of land for the Rhyd cemetery, and the completion of the relevant surveys for obtaining planning permission on it. A number of payments were approved and it was decided to consider two requests for money (young farmers and an air ambulance) at the end of the financial year depending on the budget. Monthly and quarterly finance reports were received, as well as the playing fields' quarterly reports. It was noted that there are a few things that need attention in the playing fields and that this is already underway. It was confirmed that the relevant documents for the external audit had been sent to the external auditor and the process would take up to a year to complete. Options to receive card payments for parking tickets were discussed, with further discussion required before coming to any agreement. The committee will be meeting on Monday evening to discuss advertising the clerk's position.

5.2 Parciau a Mannau Agored / Parks and Open Spaces

Daethpwyd a nifer o faterion at sylw'r Cyngor gan Elfed Jones. Trafodwyd y cytundebau torri gwair a chynnal llwybrau gan nodi bod angen bod mwy cadarn am amseru'r gwaith. Bu rhannu manylion cyswllt y contractiwr gydag Elfed Jones. Nodwyd bod cyfarfod safle wedi cymryd lle y llwybr ger Derwyddfa a'i fod bellach wedi ei ail-agor a'i ddiogelu.

Bydd y pwyllgor yn cwrdd nos Fawrth 24/10/2023 i drafod byrddau gwybodaeth y pentref – Elfed Jones i gydlynnu. Cytuno byddai'r cyfarfod yn agored i unrhyw gynghorydd nid dim ond aelodau'r pwyllgor.

A number of issues were brought to the Council's attention by Elfed Jones. The grass cutting and path maintenance agreements were discussed noting that there needs to be more firmness about the timing of the work. The contractor's contact details were shared with Elfed Jones. It was noted that a site meeting had replaced the path near Derwyddfa and that it had now been re-opened and protected.

The committee will meet on Tuesday night 24/10/2023 to discuss the village's information boards - Elfed Jones to coordinate. Agreed the meeting would be open to any councilor not just committee members.

5.3 Pwyllgor yr Harbwr / Harbour committee

Cafwyd ddiweddariad gan Dafydd Williams yn sgil absenoldeb Brian Potter. Cafwyd gadarnhad gan Derek Owen byddai swyddogion CSYM yn ymweld a'r pier yn fuan er mwyn asesu'r gwaith sydd ei angen ac o bosib cwblhau archwiliad manwl. Fe allai fod arian Llywodraeth Cymru ar gael tuag at unrhyw waith sydd ei angen.

Dafydd Williams gave an update due to Brian Potter's absence. Derek Owen confirmed that IACC officers would visit the pier soon in order to assess the work required and possibly complete a detailed inspection. Welsh Government funding may be available towards any work required.

5.4 Port St Mary

Bu'r clerc gadarnhau bod y rhybydd cyntaf wedi ei baratoi gan CSYM. Os na fydd cais am etholiad erbyn y cyddiad cau, bydd ail rhybydd er mwyn cyfethol. Cadarnhawyd byddai etholiad yn gost o £2500 i'r cyngor cymuned.

The clerk confirmed that the first notice had been prepared by the IACC. If there is no request for an election by the closing date, there will be a second notice in order to co-opt. It was confirmed that an election would cost the community council £2500.

Agreed to invite Alun Roberts, highways officer to attend the next meeting of the Community Council. A copy of the invitation will be sent to the three county members.

Croesawyd Mrs Roberts i'r cyfarfod a diolch iddi am anfon rhestr o bryderon i'w trafod ymlaen llaw. Aethpwyd drwy'r rhestr un fesul un a'u trafod mewn manylder. Bu nodi mai cyfrifoldebau CSYM oedd yn mwyafrif a bu Derek Owen gadarnhau y byddai y cysylltu a'r swyddogion perthnasol i dynnu sylw a/neu gofyn am ddiweddariad.

Bu cytuno byddai trefnu cyfarfod gyda Rhys Williams ar ddiwedd y tymor i drafod ei gytundebau cynnal a chadw ar ddiwedd y flwyddyn gyntaf. Nodwyd bod nifer o fanion i'r Cyngor Cymuned ei gwblhau dros gyfnod y gaeaf megis torri iddew, glanhau meinciau, gwella'r llwybr drwy'r cae chwarae.

Mrs Roberts was welcomed to the meeting and thanked for sending a list of concerns to be discussed in advance. Each point was discussed in turn in detail. It was noted that the majority were IACC's responsibility and Derek Owen confirmed that the relevant officers would be contacted to make them aware and/or ask for an update.

It was agreed that a meeting would be arranged with Rhys Williams at the end of the season to discuss his maintenance contracts at the end of the first year. It was noted that there were a number of items for the Community Council to complete over the winter period such as cutting ivy, cleaning benches, improving the path through the playing field.
